

****PRIVACY POLICY IN ACCORDANCE WITH ACT NO. 18/2018 Z.z.****

****1. Data Processor****

We are committed to protecting and respecting your privacy. Due to new legislation and in compliance with current data protection regulations, we are providing an update form to grant consent for the processing of personal data. The Privacy Policy provides information, purpose, and conditions under which personal data of data subjects – clients – are processed.

****2. Purpose of Personal Data Processing****

****3. Scope of Personal Data Processing****

We do not collect or process any sensitive personal data. The conditions for personal data processing are established by generally binding legal regulations, and both the controller and the processor comply with them and adhere to data protection conditions in accordance with Act No. 18/2018 Z.z.

****4. Legal Basis for Processing****

The collection of personal data is carried out solely based on the consent of the data subject using an Update Form, which stores documentation regarding the individual's consent.

You may withdraw your consent at any time by clicking the link at the end of the newsletter or by emailing: info@gazdovskydvor.com. Withdrawal of consent will not affect the lawfulness of processing based on consent before its withdrawal.

****5. Disclosure of Personal Data to Third Parties****

Without your consent, we will not provide your information to any third parties except:

- Partner service providers with whom we have a contractual relationship,
- Individuals who have an employment or similar relationship with SKI3 s.r.o. to provide you with responses on behalf of our company.

****6. Cooperation with Data Processor****

SKI3 s.r.o., IČO: 36402826, DIČ: SK2021608886, based in Gazdovský dvor 159, 03483, Bešeňová, is responsible for ensuring that the data processor complies with these principles and the relevant legal regulations to ensure the protection of personal data. In the event of a change in the data processor, our clients will be informed via the website www.gazdovskydvor.com.

****7. Retention Period and Rights of Data Subjects****

Personal data will be retained until the data subject withdraws their consent for the specified purpose. If the processed personal data is no longer necessary, it will be securely deleted or anonymized. At any time, the data subject has the right to request access to their personal data, correction, deletion, restriction of processing, or to object to processing.

****8. Use of Cookies and Web Beacons****

We use cookies and web beacons to collect information while navigating www.gazdovskydvor.com. Web navigation information includes standard browser data such as browser type, IP address, and actions performed on the website, such as viewed pages and clicked links. These serve to improve website functionality, collect statistical information, and ensure security.

Cookies and similar technologies help customize the website according to client preferences, processes, and needs, as well as detect and prevent security threats and misuse. Used alone, cookies and web beacons do not personally identify you.

****9. Online Accommodation Sales****

For SKI3 s.r.o., compliance with data protection principles is an integral part of all company activities. Personal data is processed strictly for the purposes of online ticket sales, online accommodation bookings, and marketing activities. The scope of personal data processed for marketing includes name and email address, and for online purchases, it includes name, address, email, and billing details.

The data subject may voluntarily grant SKI3 s.r.o. consent for marketing purposes, particularly for sending promotional materials (newsletters) related to the services offered.

By granting consent, the data subject confirms they have been informed about the purpose and their rights outlined in this Privacy Policy.
